



## **Redeemer Presbyterian Church**

**Called Congregational Meeting  
Covenant Hall**

**Sunday, September 18, 2022**

A called congregational meeting of Redeemer Presbyterian Church in Redeemer's Covenant Hall was called to order at 9:56 a.m., at the conclusion of the 8:45 a.m. Divine Service, by Teaching Elder Eric Landry as Moderator. TE Landry opened the meeting in prayer. TE Landry announced that, as determined under Section 25-3 of the Book of Church Order of the Presbyterian Church in America, a quorum was present.

Notice of the called congregational meeting had been given to the congregation in accordance with Section 24-1 of the Book of Church Order and Section 5 of the Redeemer By-Laws through announcements during the Divine Service, emails and online publication, and in the announcements section in the back of the printed Order of Worship.
